NOTES TO BE READ WHEN COMPLETING THIS APPLICATION FORM

1. Where a survey for the issue of an Airworthiness Certificate is to be carried out overseas, the applicant must include a letter stating that they accept all additional costs. These costs include overseas travel, subsistence and accommodation.
2. Failure to declare all known modifications can delay the issue of a Certificate of Airworthiness. Any modifications listed must be supported by documentation defining the modification, demonstrating its approval status, and including any applicable flight manual supplements.

It is the owner's responsibility to establish and demonstrate that the modifications have been approved to a standard acceptable to the SCAA. Modifications installed that do not have the appropriate approval will need to be approved prior to issue of the Certificate of Airworthiness.

The SCAA may wish to investigate modifications or equipment previously approved by other airworthiness authorities. The applicant should identify the method of approval by other Authorities (such as the issue of an STC) as this can be of assistance in obtaining SCAA approval. The applicant should also be aware that the SCAA may require flying the aircraft for test purposes.

3. The Airworthiness Notice No.12 provides further information on the procedures associated with the issue of a Certificate of Airworthiness.
