**NOTES TO BE READ WHEN COMPLETING THIS APPLICATION FORM**

1. Where a survey for the issue of an Airworthiness Certificate is to be carried out overseas, the applicant must include a letter stating that they accept all additional costs. These costs include overseas travel, subsistence and accommodation.
2. The extension of the validity cannot exceed 1 month from the date of expiry of the Certificate of Airworthiness.
3. The Airworthiness Notice No.16 provides further information on the procedures associated with the renewal of a Certificate of Airworthiness.
